I am writing this in response to your email dated April 11, 2008. As for your request I was never in possession of any customer list of Home Team Advantage Inc., therefore it would be impossible to return what I do not have. Nor have I started contact with any customers of Home Team Advantage, they have contacted me. You are trying to infringe on my constitutional rights, restricting my rights to contact any government or consumer protection agencies or any parties that I see fit talk to about by experience with Home Team Advantage. I have not used any privet information of Home Team Customers; any information used was with the permission of the people that contacted me. As the registered owner of the Domain www.hometeamdisadvantage.com and can use my website as I see fit. There is no benefit or profit gained from this web site; I am just doing my part to protect my fellow Florida homeowner. Everything that is stated on my web site is true. There are no false allegations as to permitting or any other issues. Home Team Advantage failed to apply for permits required by law to do my job, until they were caught by Broward County's Building Department.

All the facts that are on my web site are either public records, or documented facts about what has happen with my job. I will continue to use my website to tell the facts of my experience with Home Team Advantage, employees of, and sub-contractors. According to Public records Indecor is owned by Doug Livingston, which is also the located at the same address as Home Team Advantage Inc. There are no false statements on the website.

I do not feel that my job is completed as agreements have been made with Home Team Advantage and not honored, nor has the contract been completed. I have, at the request of your client already mailed these issues to John Ostendorf, President of Home Team Advantage Inc. via Certified Mail, 7007 1490 0001 0321 4760, on February 27, 2008. It was signed for at his office on February 29, 2008. I suggest you obtain this letter from your client.

As per the contract that was signed with Home Team Advantage, you do not have the right to file any law suit. According to the contract “IN ANY DISPUTE BETWEEN THE CUSTOMER (S) AND HOME TEAN ADVANTAGE, INC., BOTH PARTIES AGREE TO SETTLE DIFFERENCES IN MEDIATION.”

With the hope of resolving the pending issues, despite all my documented efforts, he has refused to contact me, even after promising to do so. If you are able to arrange such a meeting, at your office, so that we can settle these problems your help would be greatly appreciated.
